Program Concept and Objectives:









The industry is seized of the need for a comprehensive and integrated approach to Insurance Fraud Management, for which academic certification is a key concern.

To address this concern of the industry, III has designed its **Certified Insurance Anti-Fraud Professional (CIAFP)** course in association with North American Training Group (NATG). The objective of the Course is to cover all academic and practical aspects of Fraud Fighting, Fraud Detection cum Investigation and Fraud Prevention in Insurance.
