Hence, insurers pay a lot of attention to claims in these portfolios and are very careful in evaluating risks and building loss control measures into the policy.

Property insurance professionals appreciate the importance of separate functions like risk management, underwriting, loss prevention and claims control as well as claims processing as areas of expertise. They also understand the need for integrated learning across functions, so that professionals can develop common approaches and strategies at company/ industry levels. In addition, each company would have its own internal risk appetite, strategies, pricing systems, and procedures for underwriting, claims processing etc.
