Program Concept and Objectives:

Audit is an integral part of Risk management in any organization. Audits are part of the Corporate Governance and Regulatory practices of the Indian insurance companies. While most audits look into accounting aspects and prevent unethical practices, technical audits serve an objective assessment of the internal norms, systems, procedures, practices and violations thereof in the insurance company context.

Technical Audits focus on the technical aspects of the insurance business operations. This would include multiple aspects such as, (a) assessing the underwriting practices, the selection of risks, and pricing of policies, etc., (b) checking whether the company is accepting risks in a prudent manner, without compromising on the long-term financial stability of the insurer, (c) ensuring that the claims management process is efficient, fair, and timely, (d) ensuring the soundness of reinsurance arrangements, (e) checking compliance with prescribed regulatory requirements like underwriting guidelines, product development and pricing norms, claims settlement norms, investment regulations, financial reporting requirements, etc. College of Insurance has curated this program to sensitize professionals of the importance and purposes of Technical Audit and ensuing compliances.
