In agricultural insurance, a surveyor plays a crucial role in assessing risks, determining the extent of damage, and facilitating the claims settlement process. The surveyor performs on-site inspections, gathers pertinent data, and gives insurance companies reliable information in their capacity as a field expert. However, they deal with a number of difficulties and complexities while evaluating losses. These difficulties result from the dynamic character of agriculture, the wide range of variables affecting crop health, and the requirement for impartial and precise evaluations. Variable weather conditions, disease and pest management, availability of accurate data, technological constraints, time constraints, regulatory compliance, documentation and reporting etc. are some of the typical issues that surveyors encounter when estimating losses in agricultural insurance. In addition, there could be subjective factors in loss assessment.

To help upcoming surveyors appreciate the nuances of this market segment, COI has designed this program on a Virtual Classroom mode. COI has created 'Virtual Training (CVT) Rooms' as a cost-effective mechanism for participants to equip participants academically at their respective locations.
